### ORDINANCE NO. 98-079

AN ORDINANCE AMENDING CERTAIN SECTIONS OF CITY ORDINANCE NO. 92-008, AS AMENDED, ENTITLED: "REVENUE ORDINANCE OF THE CITY OF ZAMBOANGA AND PROVIDING PENALTY THEREOF."

Be it ordained by the Sangguniang Panlungsod of the City of Zamboanga, that:

SECTION 1.- An Ordinance Amending Certain Sections of City Ordinance No. 92-008, as Amended, Entitled: "Revenue Ordinance of the City of Zamboanga and Providing Penalty Thereof."

SECTION 2.- Section 24 (a) of City Ordinance No. 92-008, as amended, is hereby further amended to read as follows:

SECTION 24 (a).- On Manufacturers, Assemblers, Repackers, Processors, Brewers, Distillers, Rectifiers and Companies of liquors, distilled spirits and wines or manufacturers of any article of commerce of whatever kind or nature with the following schedules:

SECTION 24. (h). Tax on pawnshops, money shops, lending investors, finance and investment companies, insurance companies, banks, stock markets, stock brokers and dealers in securities and foreign exchange and other financial institutions, except the Bangko Central Ng Pilipinas, at the rate of Eighty Two (82%) percent of one percent on the gross receipt of the preceding calendar year derived from interests, commissions and discounts from lending activities, income from financial leasing, dividend, rentals on property and profit from exchange or sale of properties and insurance premiums.

SECTION 9. Section 24 (i) is hereby amended to read as follows:

SECTION 24 (i). Real State Lessee and Lessor of Movable Property. – Lessor of Real Estate and Movable Lessor of Real Property based on 3.03% of the Gross Receipts of the precedding year.

Section 24 (p). Tax on Delivery truck, or Van or any vehicle used of Manufactures, Producers, Wholesalers or Dealer/Retailers in certain products.

Manufacturers, Producers, Wholesalers, Dealers or Retailers, in the delivery or distribution of distilled spirits, fermented liquors, softdrinks, cigars and cigarettes and other products to sale outlets or consumer's whether directly or indirectly, within the city –P- 750.00 tax per annum and –P- 100.00 Regulatory Fee.

SECTION 15.- Repealing Clause. - City Ordinance No. 94-021, is hereby repealed in its entirety.

SECTION 16.- This Ordinance shall take effect on January 1, 1999.
